On November 19, 1863, President Lincoln gave his most important speech, the famed Gettysburg Address. In that address, President Lincoln noted that we were "engaged in a great civil war" testing whether our nation would survive. No one can suggest that the battle surrounding the use of independent contractors in the transportation industry rises remotely to the level of importance of the survival of our then young nation. But this battle, and the never-ending attacks on the independent contractor model at the federal and state level, challenges many of our clients to the point of threatening the financial viability of some. This panel will address those challenges, inform attendees on the status of significant litigation, and provide regulatory and statutory updates relating to the use of independent contractors in transportation.
